**SALEM LUTHERAN CHURCH

#CR2001-12**

WHEREAS, a new organization structure was created by Continuing Resolution #CR2001-01, passed February 20, 2001, and

WHEREAS, it has now been found necessary to make several technical corrections to that resolution to reflect appropriate terminology and omitted items;

NOW, THEREFORE, BE IT RESOLVED that the Congregation Council of Salem Lutheran Church hereby amends CR2001-01 with the following changes:

1. That the diagram on Page A-1 include a reference to the existence of a Call Committee in times when the Senior Pastor position is vacant.
2. That wherever the words "Vacation Church School", "Disciple Formation", and "Family Life Coordinator" appear, the words should be changed to "Vacation Bible School", "Confirmation", and "Youth and Family Ministry", respectively.
3. On Page C-1, delete all parenthesis, the words inside parenthesis, and add an Item Nine: "4th-6th Grade Youth Group".
4. In Section E, on the form for Chartering a Task Force, add the words "and file a copy of all written reports, including a final recommendation, with the Congregation Secretary".
5. In Section E, on the form for Chartering a Task Force, add the words "monies needed for the implementation of a recommendation, must be approved through the normal financing mechanisms in place for church related ministries".
